

INSTRUCTIONS AND GUIDELINES FOR SOLICITING LOCATION PREFERENCE
FOR THE POSITIONS OF FEMALE HEALTH WORKER (ANM) AND CONTRACTUAL STAFF NURSES
ONLINE WRITTEN TEST WAS HELD ON JULY 30 & 31, 2021
NATIONAL HEALTH MISSION, MADHYA PRADESH

An online application has been developed for soliciting Location preferences from the candidates shortlisted in the written test for the positions Female Health Worker, ANM and Contractual Staff Nurses under National Health Mission, Madhya Pradesh. Candidate can provide his/her location preference through the online application form.

Following are the steps, process, and instructions for providing the location preference:

- (1) Candidates need to login on Online Application from link for Female Health Worker ANM position: <https://qm.samshrm.com/prefupdateANM/> and for Staff Nurse Position: <https://qm.samshrm.com/prefupdateSN/> with their Application Number/Roll Number and DOBs;
- (2) Candidates need to choose the locations from the dropdown box to provide their preferences of Locations for the allotment.
- (3) Candidate must provide the preference for minimum 100 locations. In case they don't opt to provide preferences for minimum 100 locations their candidature shall be considered for all the locations and for such candidates, a random location shall be allocated to them;
Note: Without providing the minimum 100 locations preferences in the online location preference form, candidates shall not be able to submit their location preferences.
- (4) **Signing of the self-declaration:** "I fully understand that details of location preference, as above, are being solicited for information purposes only. Job postings shall be decided on the overall merit rank and location preferences of the selected candidate and in case of location preferences provided by me get exhausted, a random location shall be allocated. I fully agree to abide by the location of posting determined by **NHM, MP** through the above process or as per their discretion and availability of the locations."
- (5) Preview of selected location and preferences before final submission;
- (6) Final submission of location preference shall be based on One Time Password (OTP), OTP shall be sent on Registered Mobile Number (RMN), the candidate shall submit the form after inputting the right password (OTP) sent on RMN;
- (7) Four (4) days of the time period shall be given for submission of the location preferences starting from **September 25, 2021, 4:00 pm till September 29, 2021, 3:59 PM** for the above positions which written test was held on **July 30 & 31, 2021**.

Note:

- (a) Candidates shall be able to modify the Location Preferences till the last date of submission. In case of extension on the last date, previous submitted location preferences details cannot be modified.
- (b) Candidates who fail to provide location preference within the above stipulated period or any extension period, for such candidates' 'random location' allotment shall be done.
- (c) Rule book clause No. 6.12, which states that the candidate can give the location preference for a maximum of 10 locations, has been modified. Now candidates can provide the preference for minimum 100 locations.
